- a) Village Hall The fete is on 24 June between 1 4pm. The steam museum will be open and tractor and trailer rides between the two locations will be available. Further improvements have been made to the car park and the Chairman passed on his thanks to the parish council, on behalf of the village hall, for the donations.

and meeting of local footpath wardens — The Chairman reported that he met with Bob West, Highways Engineer, to discuss several issues, including the drainage on Tabernacle Lane. Permission was also obtained to undertake a bulb planting exercise on some of the verges in the village. Bob asked that bulbs be planted 1 metre in from the road and not at any obvious spots where they may cause a visibility issue. Cllr Allen agreed she will try to source some bulbs, in order to get together a group to carry out some planting in the Autumn. The parish council needs to keep a record of where the planting has taken place.

The Chairman reported that proposed sewer works due to take place imminently, between Forncett and Bunwell, have been postponed until October. County Councillor Spratt mentioned complaints from residents of William Lant Close about the noise caused by a loose Anglian Water drain cover. The clerk will follow this up.

Bob Smith, Chairman of Bunwell Parish Council, reported on a very successful meeting of footpath wardens and walkers. Bob is trying to arrange some clusters of parish councils who can work together to maintain their footpaths, without the meetings and correspondence becoming too big to manage. Bob passed on his thanks to John Wilde, footpath warden for Forncett and Tacolneston, for his help and advice. It was noted that John Wilde, Brian Frith, Graham Gale, Derek Hill and Terry Hickman-Smith have all carried out work on the footpaths, on a voluntary basis.

- **c) SAM2 report** Phil Whiscombe reported that the SAM2 machine has recorded over 540,000 vehicle movements, with 46% of those vehicles exceeding the speed limit.
- **d)** Co-op community token scheme Cllr Welsby provided further information about this scheme and agreed to investigate how to apply, with a view to any funds collected being used to manage the Station Road Land.

14. To receive reports from:

a) Safer Neighbourhood Police Team Report - including report from meeting with Police representatives at Long Stratton – The most recent figures available are for March 2017, which show two violent offences committed in the village.

The Chairman attended a recent police meeting at Long Stratton and was advised that parking enforcement issues are the responsibility of South Norfolk Council unless there is a safety issue. For parking at the school to be investigated, the District Council would need to attend and if they consider there is a safety issue, they will pass the matter on to the police. The clerk will contact SNC regarding this. The police also reported that most burglars access homes via doors and windows which have been left open by the householder and asked members of the public to remain vigilant.
