17. Update on ongoing matters and outstanding issues

- a) Village Hall The new windows have made a big difference to the hall, all concerned are very pleased indeed with the work. A very successful music evening was held on 15 September and tickets are selling well for the murder mystery play on 20th & 21st October. The village hall trophy quiz night will be on 10 November.
- **b) Highways and Public Rights of Way** County Councillor Spratt has raised a couple of queries, one about the culvert under Valley Farm Lane and also about an ash tree at the bottom of Orchard Close. As Councillor Spratt was not present, the clerk will try to get more details.
- c) SAM2 report Phil Whiscombe has reported little difference in the statistics this time. Highway have installed a new post on Long Stratton Road, so this can be used as a new SAM2 location. The new 40 mph speed limit is in force on Station Road, so it is hoped to site the sign in this location as well, at some point in the future. It was agreed to purchase two additional sets of brackets, in order to facilitate this.
- **18. Open forum, to hear from members of the public** A member of the public asked, now that all of the houses at Hunt's Mead have been sold, if it would be possible for all the flags and banners to be taken down. A query was also raised about the maintenance of the boundary hedge on the road at the approach from Long Stratton. The clerk will contact South Norfolk Council regarding these queries.
- 19. To confirm the date of the next meeting as 18 October 2018.
