- 4. To consider matters arising from the minutes (for information only) Following up from a query raised last month regarding issues at Long Stratton Surgery, Councillor Carsok included an item in her report advising that she has recently spent a morning at the surgery to see the scale of the problem. The building work is now complete and the surgery is actively trying to recruit to vacant posts so it is hoped the situation will improve as quickly as possible.

- **9. To report information relating to trees on the Station Rd land –** The tree works at the land on Station Road have been completed .
- 10. To hear information relating to the clerk's annual review The parish council recommended that the clerk increase by one point on the salary scale with effect from 1 April 2024. The Chairman also asked the clerk to keep an eye an the amount of hours worked and reminded that there are funds set aside in the budget to pay for additional hours, should they be needed.
- 11. **To hear information re the forncett.info website** Richard Ball has given annual costings for the forncett.info website to be managed by the parish council as a community facility amounting to approximately £120 per year. Although the parish council has it's own website, it was agreed that the volume of information on the forncett.info website is too great to consider merging the two sites. Councillors agreed the site is an excellent resource, very well used and were happy to agree to the payment.
- 12. To report information from the Natural England / Environment Agency Flood Prevention session Councillors Humphreys, Barnes and Welsby attended this event. The event was very well attended, however, Councillor Humphreys reported that there was little structure to the evening and it could have been more helpful, particularly to those residents directly impacted by the flooding.
- **13. To consider the parish council's draft Biodiversity Policy** The draft policy was considered and councillors resolved to adopt the policy with immediate effect.
- 14. To review the following policies:
  - a) General Risk Management Minor amendments were made to the existing policy and the revised policy was approved.
  - **b)** FOI and Publication Scheme The policy was updated in accordance with the model scheme available from the ICO and the revised policy was adopted.
- 15. Ongoing Highways issues inc. Low Rd junction, village gateways, Wash Lane Ford Councillor Rowett has been pro-active in chasing up various outstanding Highways projects around the village but there still seems to be very little progress, unfortunately. The village gateways, a parish partnership project from last year, was meant to be completed last week but there is no sign of any start to the work as yet. The parish council will continue to liaise with Highways.
